
## **Head Resident**

Eric replaced Jonathan as the head resident after Jonathan moved on to his next stage of life. Eric has done a very good job in his new role. Eric is currently working for Speck Plumbing & Heating in Ames, Iowa. He finds time to attend AA meetings and attends a couple local churches. Eric has also had the opportunity to continue to develop a deeper relationship with his son. They have enjoyed time this summer at the local swimming pool, Iowa State Fair, visiting both the Des Moines and Omaha zoos, and attending his son's baseball and football activities. The two of them recently flew to Florida to spend a couple of days with Eric's family.

Eric was passionate about creating a place where the men of the Matthew 25 House and their friends could gather and spend time with each other. His vision was to turn our cluttered garage into a fitness center and rec room. As Eric and the men started the process of stripping the old cabinetry and workbenches from the garage we had a very generous offer from Theodore and Rachel. This couple was moving and wanted to donate some items to the Matthew 25 House. Their donation of a pool table, weight machine, elliptical machine, heavy bag, popcorn machine and rubberized mats to cover the floor was timely and greatly appreciated! This gift from Theodore and Rachel fit in with Eric's vision for the newly designed space. We thank Theodore and Rachel for the items that helped complete our rec area. Yet the greatest gift they gave us (at the end of a long Saturday morning of tearing down the equipment and loading it onto a couple of trailers) was Theodore sharing his testimony about how Jesus Christ changed his life. I can still see Eric and Brady leaning against that trailer with beads of sweat running down their faces absorbing each and every word that Theodore shared. The conversation back to Ames centered on the last few minutes spent with Theodore and the truth he spoke to us about his relationship with Jesus Christ. All of the donated items seemed to be secondary to us at that time.

Not long ago I received this text from Eric:

"I want to send a shout out to the big J (Jesus) for allowing us to be forgiven for our sin and to accept him as our savior so that we can have eternal life in heaven. Also another shout out to the big L (Lord) for providing this gym for the Matthew house so that not only we can get spiritually strong but also physically and for that I have a lot to be grateful." This space has provided great opportunities for the residents and their friends to meet and share in a safe area. I found out once again that I am *not* a very good pool player and, at best, an average ping pong player. I have started to lift weights four or five times a week at 5:30 A.M. with a couple of the men in the Matthew 25 House and another friend. This has been a rich time of fellowship and conversation. It has provided many opportunities to visit about things that are on our hearts. I am amazed at how God can use an old garage to influence the live of people!
